IRS Increases Standard Mileage Rate to 62.5 Cents per Mile for Remainder of 2022

The Internal Revenue Service (IRS) announced on June 9, 2022, an increase to 62.5 cents per mile for the standard business mileage rate for transportation expenses paid or incurred on and after July 1, 2022. The new rate is a four-cent increase from the previously announced rate of 58.5 cents per mile for January 1, 2022.

The IRS determined the midyear rate update was needed "in recognition of the recent gas price increases." Midyear adjustments to the standard business mileage rate are rare, with the most recent midyear update coming in 2011. In addition to the standard business mileage rate increase, the standard rate for medical or relocation purposes will increase to 22 cents per mile, up from 18 cents per mile in January 2022.

Because of the midyear timing of this change, employers should take care that they change to the updated rate for the second half of 2022 for travel that occurred on or after July 1, 2022. Business miles driven on or before June 30 should be recognized at the 58.5 cent per mile rate.

IRS Issues Revised Form 941 and Form 941-X

In June 2022, the Internal Revenue Service (IRS) issued a revision of Form 941, Employer's Quarterly Federal Tax Return, and its instructions. The IRS also revised Form 941-X, Adjusted Quarterly Federal Tax Return or Claim for Refund. The revised Form 941 can be used for the second, third and fourth quarters of 2022. The new Form 941 includes new space on Line 1 for reporting wages, tips and other compensation for the second, third and fourth quarters of the year. Also updated are lines 11e, 11f and 13f which were previously used for COBRA Premium Assistance Credits. Lines 11e, 11f and 13f are now instead reserved for future use.

Form 941-X was revised to match the changes to Form 941.

Social Security Trustees Project New Wage Base for 2023

On June 2, the Board of Trustees of the Social Security
Trust Fund issued its 2022 Annual Report of the Board of
Trustees of the Federal Old-Age and Survivors Insurance
and Federal Disability Insurance Funds. This Annual Report
includes short- and long-term projections for the Social
Security system. The projections are based upon Social
Security provisions in current law and does not consider
any changes to the legal provisions that may occur in the
future. Using forecasting assumptions, the report
estimates that the Social Security wage base will be
\$155,100 in 2023 and \$165,300 in 2024. It is important to
note that these figures are only estimates. The formal
announcement of the 2023 Social Security wage base will
be provided in mid-October 2022.

California Updates

California Supreme Court Rules Premium Pay for Missed Meal and Rest Breaks Are Wages

In May 2022, the California Supreme Court determined that premium payments made to employees for missed meal and rest breaks are considered wage payments for purposes of pay statement and payment on termination requirements. The premium pay of an additional hour of pay is required by California law when an employer requires an employee to work during all or part of required meal or rest breaks. The Naranjo v. Spectrum Security Services Inc. ruling states that the extra premium pay constitutes wages subject to the same timing and reporting rules as other types of compensation paid for work performed.

The premium pay must be reported on the itemized pay statement required under state law. Meal and rest break premium pay must be paid with other wages owed to the employee at the time of involuntary termination or voluntary termination if the individual has provided at least 72 hours advanced notice.

CalSavers Enrollment Deadline Passes on June 30, 2022

As of June 30, 2022, California employers are required by law to offer employee access to the Retirement Savings Program known as CalSavers. Employers exempt from this requirement include those who already offer a qualified retirement savings plan or those employers who have less than five employees. CalSavers will auto-enroll employees in a standard savings and investment election after an employer provides them with their payroll list. The general obligation for employers who do fall into the CalSavers Program requirement include registering for CalSavers, creating a payroll list to add employees to CalSavers, calculating the appropriate deduction for each employee, submitting the employee contributions to CalSavers and keeping the payroll list up to date. CalSavers does not have any employer fees. It also does not require any employer contributions. Employers only send in the employee contributions and they are not fiduciaries of the program.


